RESOLUTION PROVIDING FOR A PUBLIC HEARING DECEMBER 19, 1960, ON A PROPOSED AMENDMENT TO THE ZONING ORDINANCE. WHEREAS, at the meeting of the City Council on November 14, 1960, the following amendment to the City Code was introduced: Ordinance No. 709. An Ordinance Amending Chapter 21 of the City, Code - Zoning Ordinance
An Ordinance Amending the City Code with Respect to the Zoning Ordinance. BE IT ORDAINED BY THE CITY COUNCIL OF THE CHY OF CHARLOTTE: CHARLOTTE:

Section 1. That Chapter 21, Article I. Section 7 tot the City Code of the City of Charlotte. (O. B. 10), be semended by changing from Residence 1 to Office institution the following described property: Being all of Lot 6 in Block E as shown on a map of Myers Park Manor recorded in Map Book 5. Page 215 in the office of the Residence of Dead for Markhalten Company of Dead for Markhalten Com Register of Deeds for Mecklenburg, County, North Carolina. Section 2. After this ordinance shall become effective upon its AND, WHEREAS, under the law no amendment to the zoning ordinance can be adopted until a public hearing thereon is held, of which public hearing notice is required to be given publication not less than fifteen days immediately preceding the date of such hearing:
NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE THE CITY OF CHARLOTTE: 1. That December 19, 1960, at 2 o'clock p.m. be fixed as the time, and the Council Chamber in the City Hall as the place for the public hearing on the proposed amendment as above set out.
