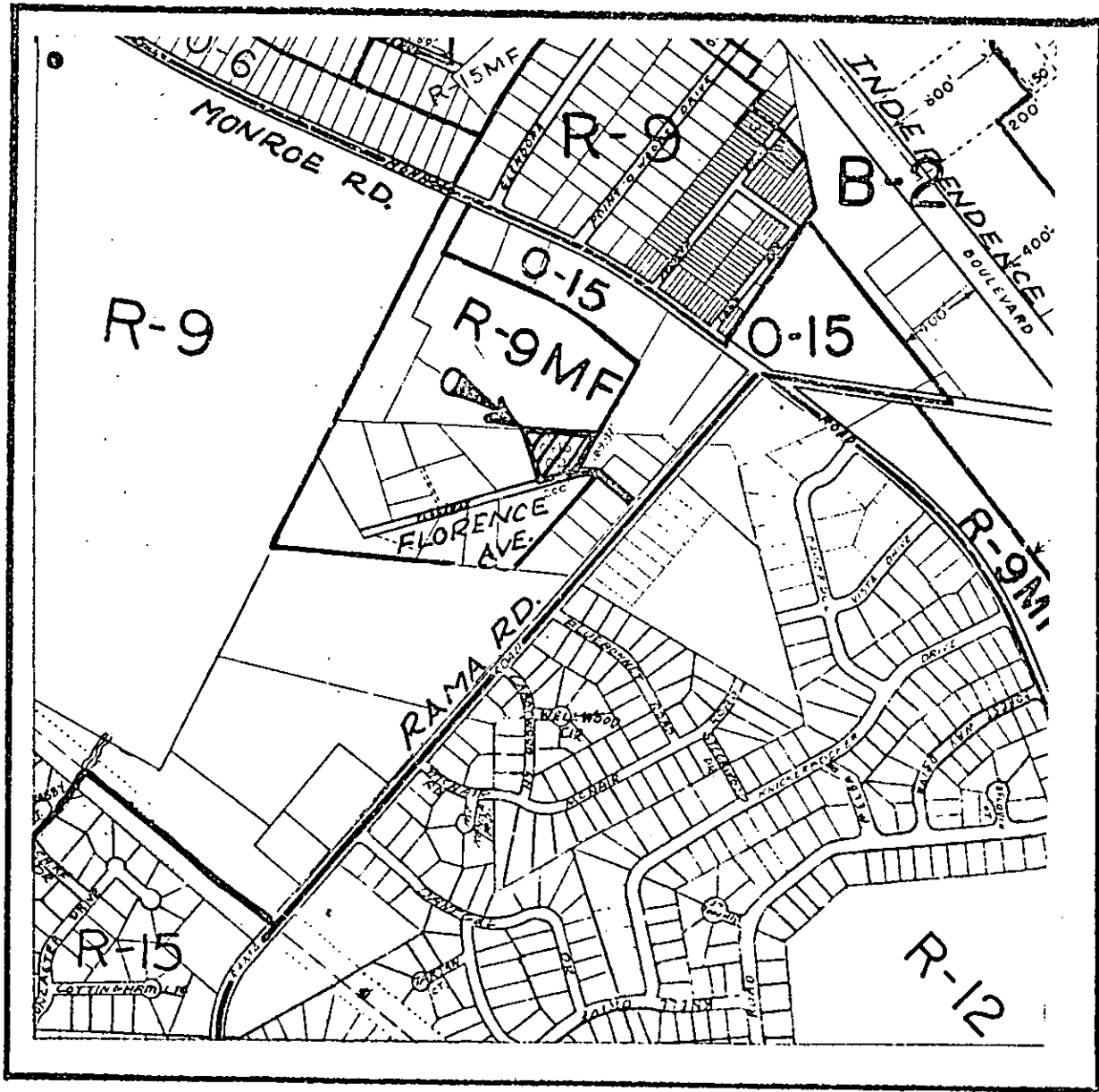

the Property is zoned properly for its best use and in keeping

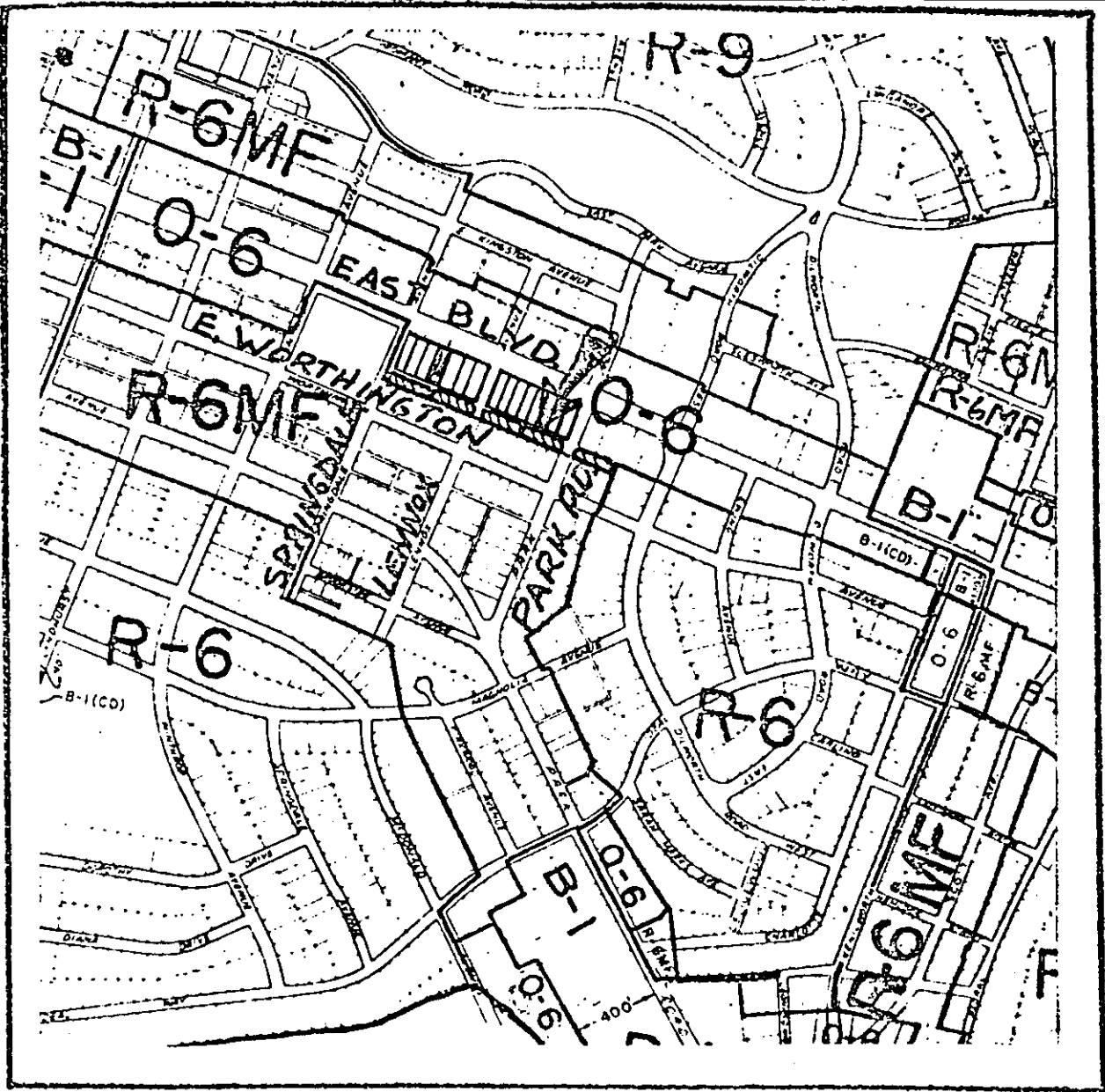
with the orderly, planned development of the area.

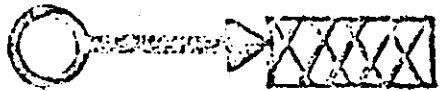
