





NOTICE OF PUBLIC HEARINGS ON PETITIONS FOR ZONING CHANGES BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE, N. C. AND THE CHARLOTTE-MECKLENBURG PLANNING COMMISSION.

NOTICE is hereby given that public hearings will be held by the City Council and the Charlotte-Mecklenburg Planning Commission on the Fourth Floor of the Education Center, 701 East Second Street beginning at 5:30 o'clock P. M. on Monday, the 15th day of January, 1979, on the following petitions proposing changes on the Official Zoning Maps of the City of Charlotte, N. C.:

PETITION NO. 79-1. Consideration of site plan revision to be previously approved B-1(CD) which also requests removal of a parcel within this present zoning to be changed to I-1, the entire B-1(CD) consists of an 8.8 acre tract fronting about 1,017.63 feet on the westerly side of Wendover Road Extension across from the interesection with Beal Street. Petitioner: The Bissell Companies, Inc.

The City Council may change the existing zoning classification of the entire area covered by each petition, or any part or parts of such area, to the classification requested, or to a higher classification or classifications without the necessity of withdrawal or modification of the petition.

Parties in interest and citizens shall have an opportunity to be heard and may obtain further information on the proposed changes from the Charlotte-Mecklenburg Planning Commission Office, Cameron Brown Building, 301 South McDowell Street.

Anyone desiring to file a written petition of protest intended to invoke the 3/4 majority vote rules as specified in G. S. 160A-385 must file such petition in the Office of the City Clerk not later than the close of business on January 10, 1978.
