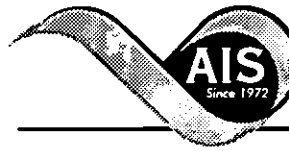

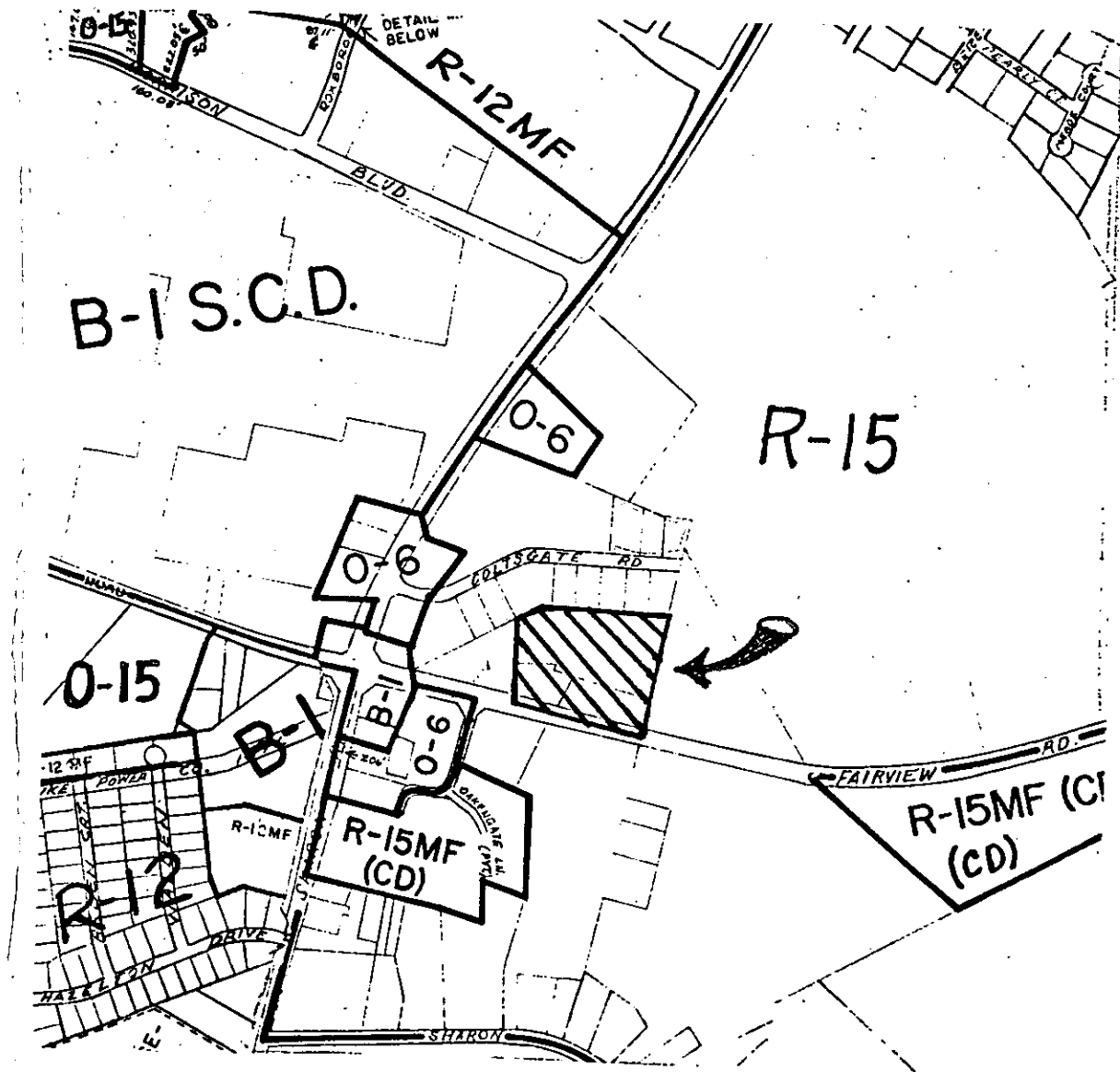

WITHDRAWAL OF PROTEST PETITION

We, the undersigned property owners, protested Petition No. 81-62 for the rezoning of approximately 6.5 acres of real property fronting 600 feet on Fairview Road and being 600 feet east of the intersection of Fairview and Sharon Roads. By this protest we invoked the 3/4 Rule.

We have reached agreement with First Colony Corporation, agent for the owners of the 6.5 acres of real property, and this agreement is evidenced by a revised site plan which was filed with the Charlotte-Mecklenburg Planning Commission on November 5, 1981.
