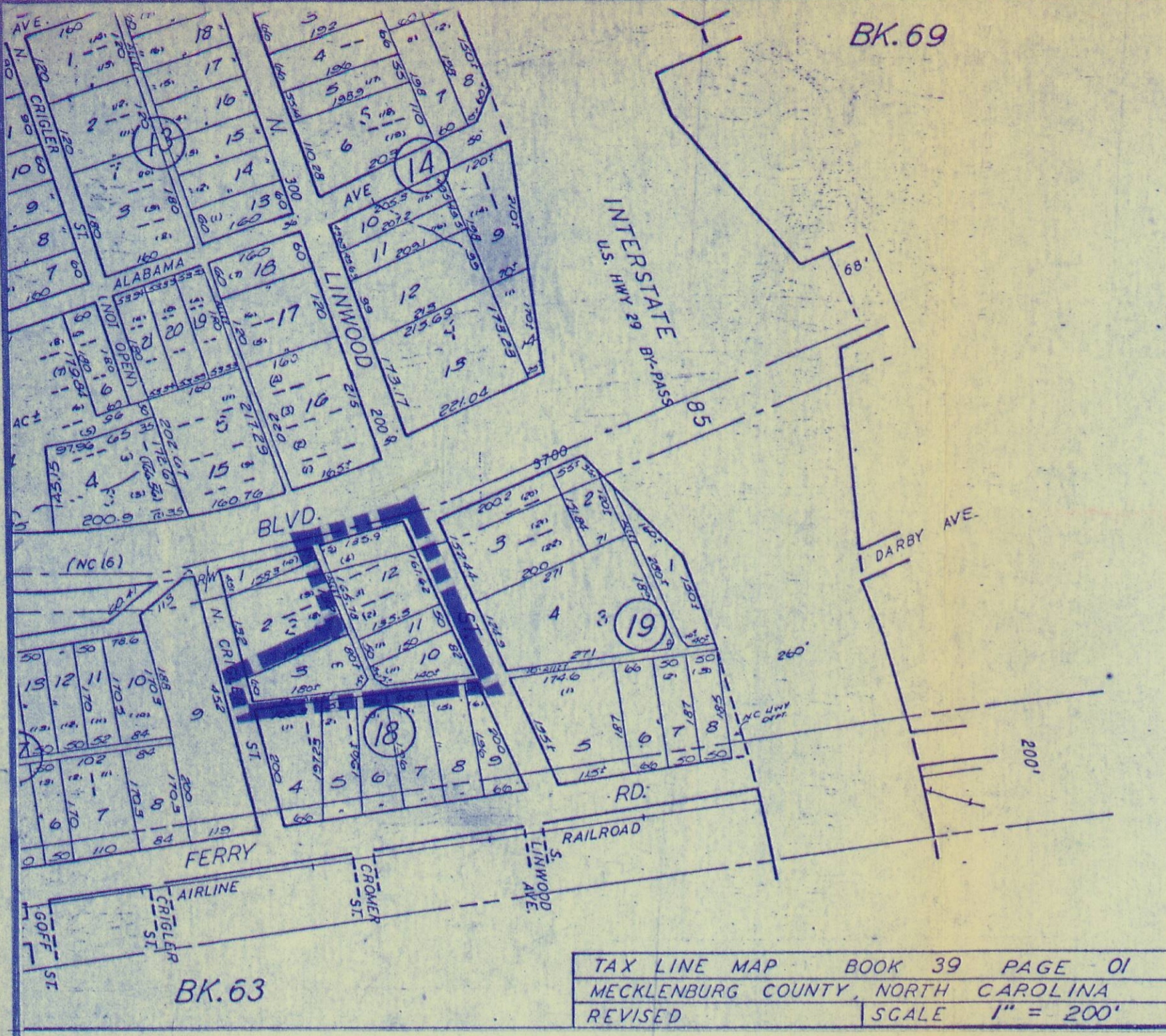


PREPARED FOR HANDY PANTRY FOOD STORES ZONING MAP

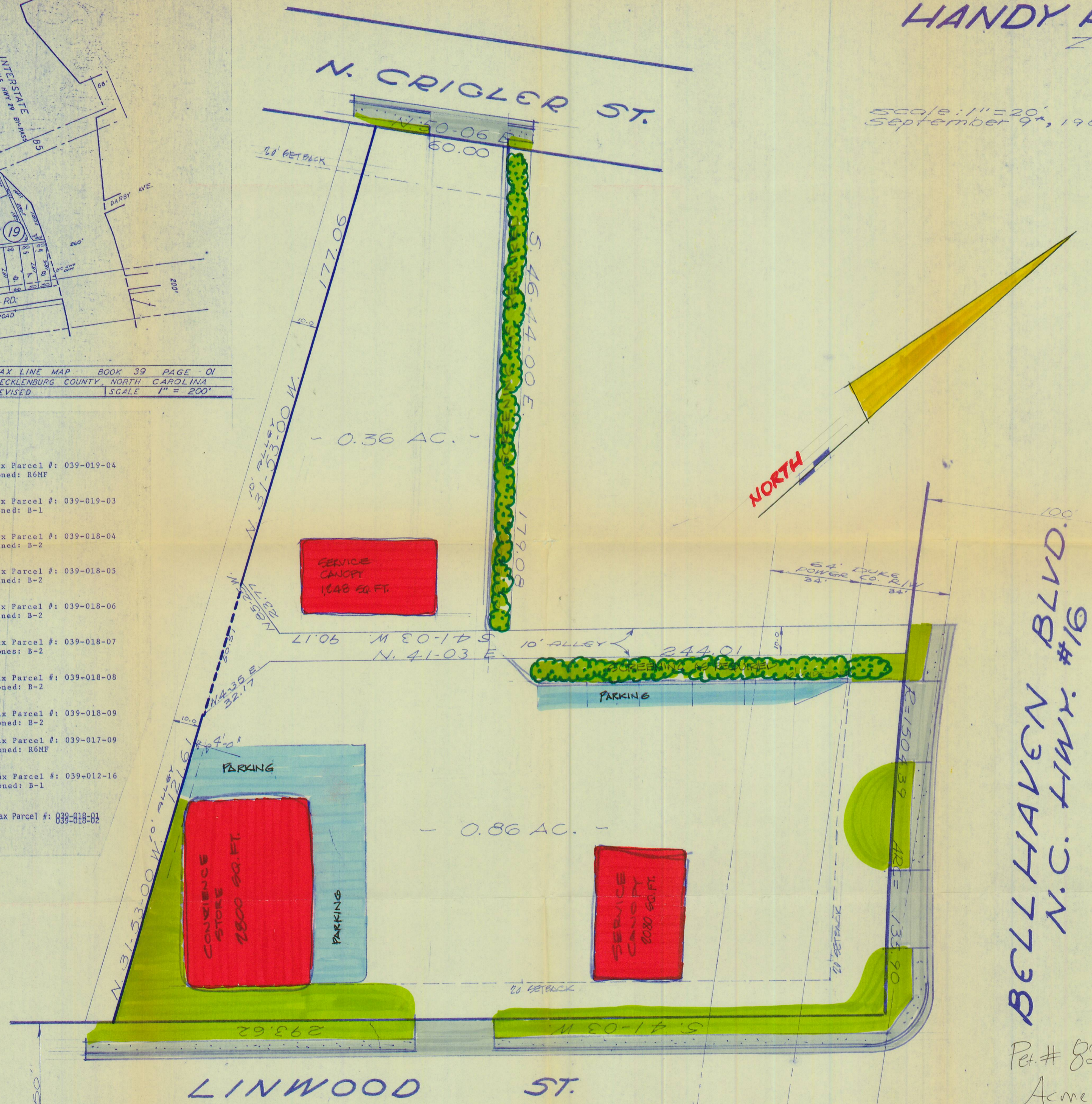


TAX LINE MAP BOOK 39 PAGE 01
