BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF MECKLENBURG COUNTY, NORTH CAROLINA:

Section 1. The Mecklenburg County Zoning Regulations as embodied in the Zoning Ordinance are hereby amended as follows:

1. Amend Section 3133.1.2 by deleting the present language in the third sentence and by substituting the following new language in its place.

A pier facility may extend over the water for a distance of 80 feet from the shore regardless of the depth. Further, a pier may extend beyond 80 feet so long as the pier does not reach beyond a depth of 10 feet measured at full pond or exceed 120 feet in length, whichever results in the shortest length, except as allowed in Section 3326 of this ordinance.

Section 2. That this resolution shall become effective upon adoption.
