




Zoning Classification (Requested): B-1(CD), R-3 and CC Site Plan Amendment

## LEGAL DESCRIPTION

BEING 1.03 ACRE OF LAND SITUATED IN THE CITY OF CHARLOTTE, MECKLENBURG COUNTY, NORTH CAROLINA, AND LOCATED ON FREEDOM DRIVE. (N.C. HWY. 27). AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT AN OLD IRON AND STONE FOUND AT THE WEST CORNER OF ELLIE MCCORD BAILEY PROPERTY (DEED BK. 1250, PG. 66) AND THE SOUTH CORNER OF MANCY D. TRICE PROPERTY (DEED BK. 6788, PG. 50);

THENCE WITH THE COMMON LINE OF TRICE AND BAILEY N 60-22-05 E 175.10 FEET TO A POINT IN THE CENTER OF FREEDOM DRIVE (PASSING AN OLD IRON AT 146.00 FEET);

THENCE WITH THE CENTERLINE OF FREEDOM DRIVE S 29-39-53-E 109.41 FEET TO THE NORTHEAST CORNER OF BAILEY AND THE NORTHWEST CORNER OF BETTY PRICE PROPERTY (DEED BK. 2488 PG. 317);

THENCE WITH THE LINE OF BETTY PRICE S 29-22-06 E 99.79 FEET TO THE EAST CORNER OF PRICE;

THENCE WITH THE SOUTHEAST LINE OF PRICE S 60-33-57 W 257.17 PEET (PASSING AN OLD IRON AT 29.30 FEET) TO AN OLD IRON FOUND HARKING THE SOUTHERNMOST CORNER OF THE BETTY PRICE PROPERTY, SAID POINT BEING IN THE LINE OF MARY HARSHALL WILLIAMS PROPERTY (DEED BK. 2062, PG. 411);

THENCE WITH SAID WILLIAMS AND PRICE LINE N 08-02-00 W 107.18 FEET TO A POINT;

THENCE WITH WILLIAMS AND BAILEY LINE N 08-02-00 W 116.86 FEET TO THE POINT OF BEGINNING, AND CONTAINING 1.03 ACRE.

THE PROPERTY DESCRIBED IS COMPRISED OF TWO PARCELS OF LAND FOR THE PURPOSE OF REZONING PETITION.
