BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF MECKLENBURG COUNTY, NORTH CAROLINA

Section 1. The Mecklenburg County Zoning Regulations as embodied in the Zoning Ordinance are hereby amended as follows:

1. Amend Chapter 9: <u>General Districts</u>, Part 2, <u>Single Family</u>, Section 9.203(7), <u>Elementary and Secondary Schools</u> and <u>Multi-Family</u>, Section 9.303(10), <u>Elementary and Secondary Schools</u>, as follows:

Add new sub-sections 7(f) as follows:

"(f) Except as modified by the requirements of sub-section 7(d) of this section, sub-sections 7(b) and 7(c) of this section shall not apply to additions, modifications, or improvements to any school that is non-conforming with respect to these provisions which was constructed, or where a building permit for the school was issued, prior to January 1, 1992."

Section 2. That this ordinance shall become effective upon adoption.
