

MINIMUM TREE SIZE AT PLANTING IS 2" CALIPER, 8" TALL IF SINGLE SREM; MINIMUM 8' TALL AND 3 STEMS MAXIMUM IF MULTI-STEM. MULCH IS REQUIRED; STACKING GUYING IS OPTIONAL.

ALL STRAPPING AND TOP 2/3 OF WIRE BASKET MUST BE CUT AWAY AND REMOVED FROM ROOT BALL PRIOR TO BACK FILLING PLANTING PIT. REMOVE TOP 1/3 OF BURLAP FROM ROOT BALL.

REMOVE COMPACTED SOIL AND ADD 24" NEW TOPSOIL / PLANTING MIX -OR-UNCOMPACT AND AMEND TOP 24" OF EXISTING SOIL TO MEET TOPSOIL/ PLANTING MIX STANDARDS FOR TREES.

ADJUST TREE PLANTING LOCATIONS TO AVOID UNDERGROUND UTILITIES -- PLANT 15-50' OFF SEWER & STORM DRAINAGE LINES; 10-15' OFF GAS WATER, PHONE AND UNDERGROUND ELECTRICAL LINES.

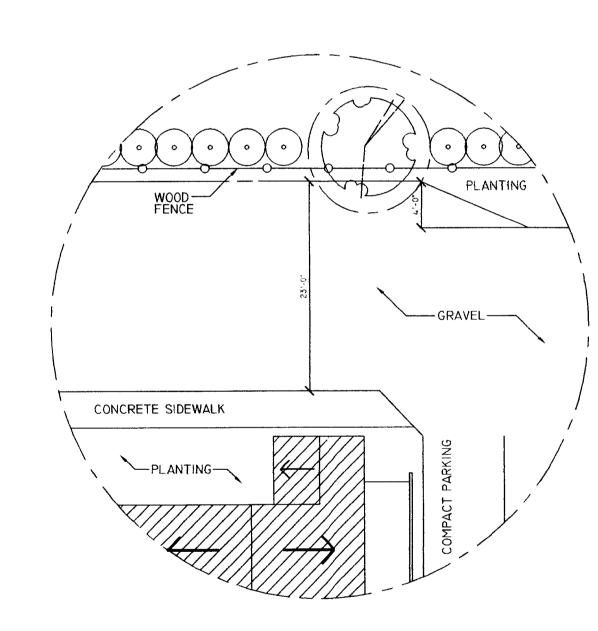

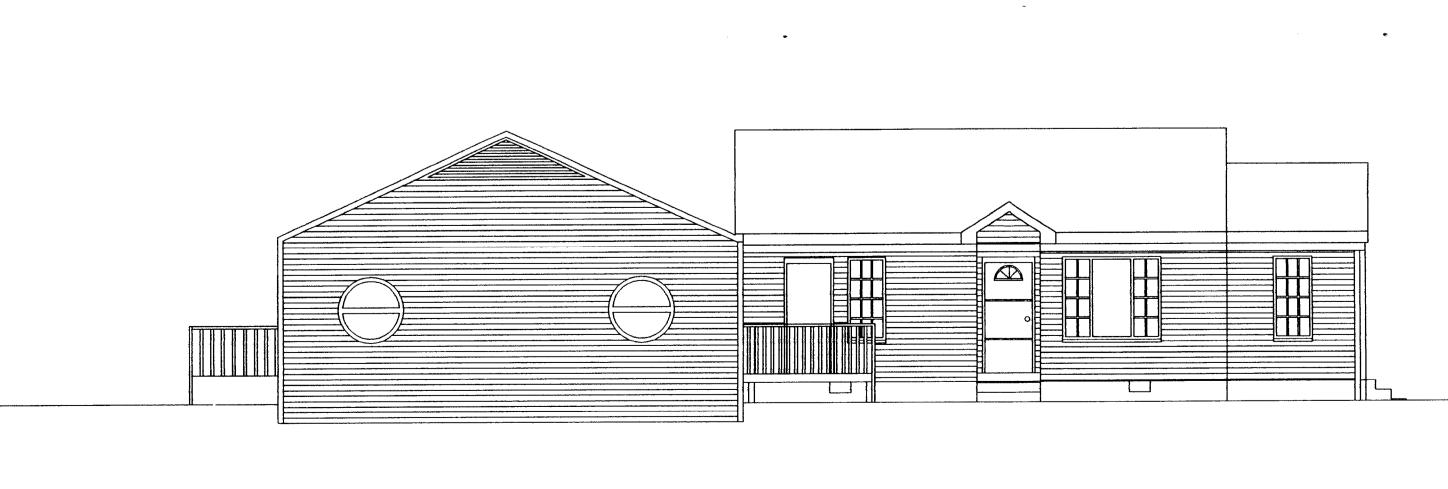
- 1.) DEVELOPMENT OF THE SITE WILL BE CONTROLLED BY THE STANDARDS DEPICTED ON THIS SITE PLAN BY THE STANDARDS OF THE CITY OF CHARLOTTE ZONING ORDINANCES.
- 2.) BUFFER AREAS WILL BE DEVELOPED IN ACCORDANCE WITH SECTION 12.302 OF THE CITY OF CHARLOTTE ZONING ORDINANCE. 3.) SCREENING WILL CONFIRM WITH THE APPLICABLE STANDARDS SET FORTH
- IN SECTION 12.303 OF THE CITY OF CHARLOTTE ZONING ORDINANCE. 4.) PARKING MEETS THE STANDARDS OF TABLE 12.202 OF THE CITY OF CHARLOTTE ZONING ORDINANCE.
- 5.) THE ONLY USE WHICH SHALL BE ALLOWED SHALL BE A DAYCARE CENTER.
- 6.) SIGNAGE SHALL CONFORM TO CHAPTER 13 OF THE CITY OF CHARLOTTE ZONING ORDINANCE LIMIT TO 4' IN HEIGHT AND 32 SQ. FT MAX... 7.) MAXIMUM BUILDING HEIGHT SHALL BE 40 FEET.
- 8.) THE DUMPSTER WILL BE SCREENED BY A 6' SOLID WOOD FENCE WITH A
- 9.) THE DRIVEWAY CONNECTION WILL BE SUBJECT TO REVIEW AND APPROVAL BY THE CDOT AND THE NCDOT.
- 10.) THE SITE WILL COMPLY WITH SECTION 12.502 (CHILD CARE CENTER) OF THE CITY OF CHARLOTTE ZONING ORDINANCE.
- 11.) ALL PROPOSED TREES, FENCES AND SIGNS WILL NOT INTERFERE WITH SIGHT DISTANCE AT THE ENTRANCE OF THE SITE. ANY FENCE REQUIRING A CERTIFICATE WILL BE OBTAINED FROM THE CDOT.
- 12.) EXISTING TREES IN BUFFER ARE TO REMAIN. 13) ADDITIONAL RIGHT OF WAY ALONG BEATTIES FORD RD WILL BE DEDICATED
- PRIOR TO ISSUANCE OF CERTIFICATION OF OCCUPPANCY. 14.) SHRUBS WILL BE PLANTED ALONG THE FENCE LOCATED IN THE FRONT SETBACK. TO TOTAL 50' FEET FROM THE CENTERLINE.
- 15.) A STANDARD 2"-6" CURB AND GUTTER, ASSOCIATED STORM DRAINAGE AND 5' SIDEWALK AND 8' FEET PLANTING STRIP ALONG BEATTIES FORD ROAD
- 16.) IF ADJACENT PROPERTY ZONING CHANGES, THE BUFFER REQUIRED FOR THIS PROPERTY MAY BE REDUCED TO MEET THE PROPER REQIUREMENT FOR THAT ZONING CRITERIA.

GENERAL NOTE

- 1.) BUFFERS SHOWN WILL NOT BE REDUCED IN WIDTH FROM THAT SHOWN. 2.) NO STORMWATER DETENTION IN BUFFERS OR SETBACKS.
- 3.) OUTDOOR LIGHTS WILL BE LIMITED TO 15' FEET.
- 4.) EXISTING BUILDING TO BE USED AS DAY CARE AND THE ADDITIONS WILL BE ARCHITECTURALLY COMPATIBLE WITH PITCHED ROOFS.
- 5.) PLAY SPACE CANNOT BE LOCATED WITHIN BUFFER OR SETBACKS/YARDS. 6.) CHAIN LINK FENCE MUST BE LOCATED OUTSIDE OF BUFFER. 7.) CONTRACTOR TO PROVIED WOOD TIMBERS ALONG THE PERIMETER OF THE
- PARKING LOT EXCEPT AT THE ENTRANCE AND EXIT. 8.) THE SIDEWALK MAY REANDER AND THE PLANTING WIDTH MAY VARY TO
- SAVE TREES 6" IN CALIPER AND LARGER. 9.) THIS PROJECT MAY BE COMPLETED IN PHASES.
