Non-residential Uses include up to 70,000 SF of Amenity & Service Areas, Outpatient Dialysis (up to 20) and relocation of existing Environmental Services (offices, maintenance & grounds keeping). Rezone existing R-17MF (10.4124 AC) to be contiguous Zoning with existing INST(CD).
 (2) Revise existing R-17MF in its entirety of (10.4124 AC) to (6.5109 AC) for Total Rezoning Acreage of 87.4109 AC.
