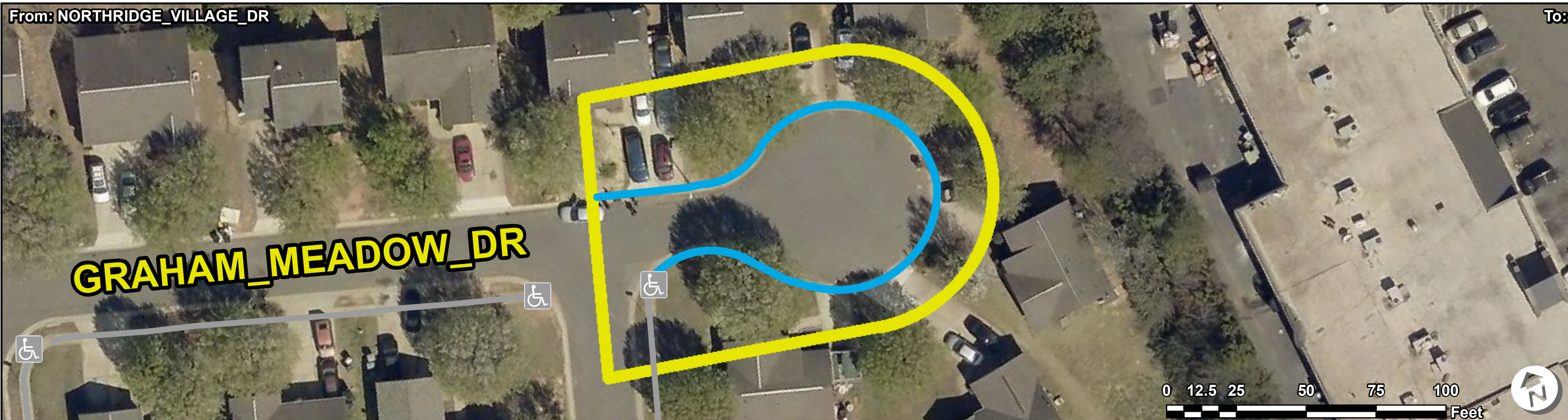

Running Slope

5 - 8.33%
8.34% - 10%
10.01 - 12.5%
