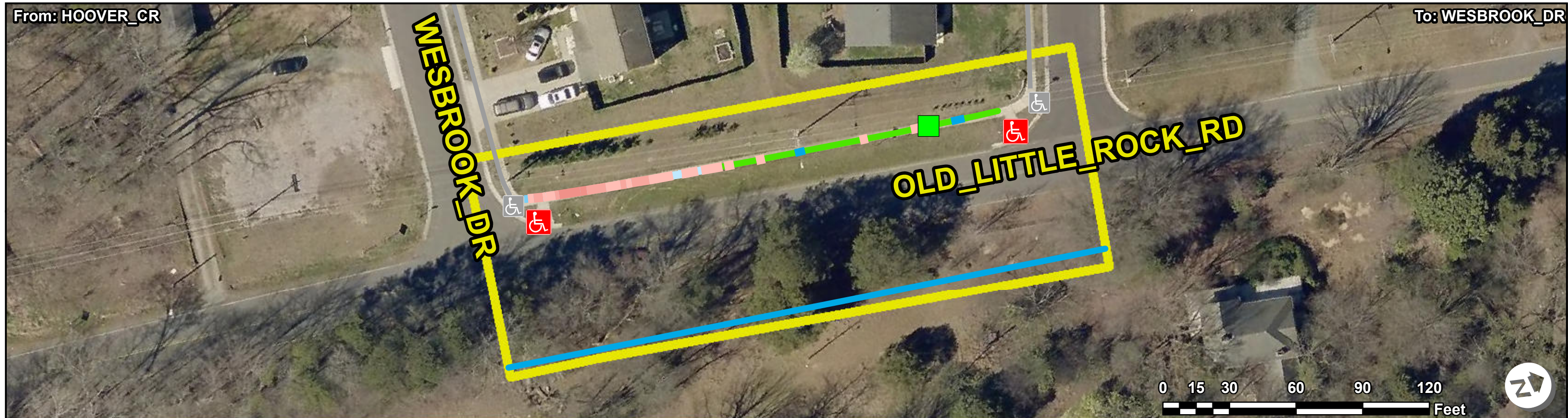

Other Features
