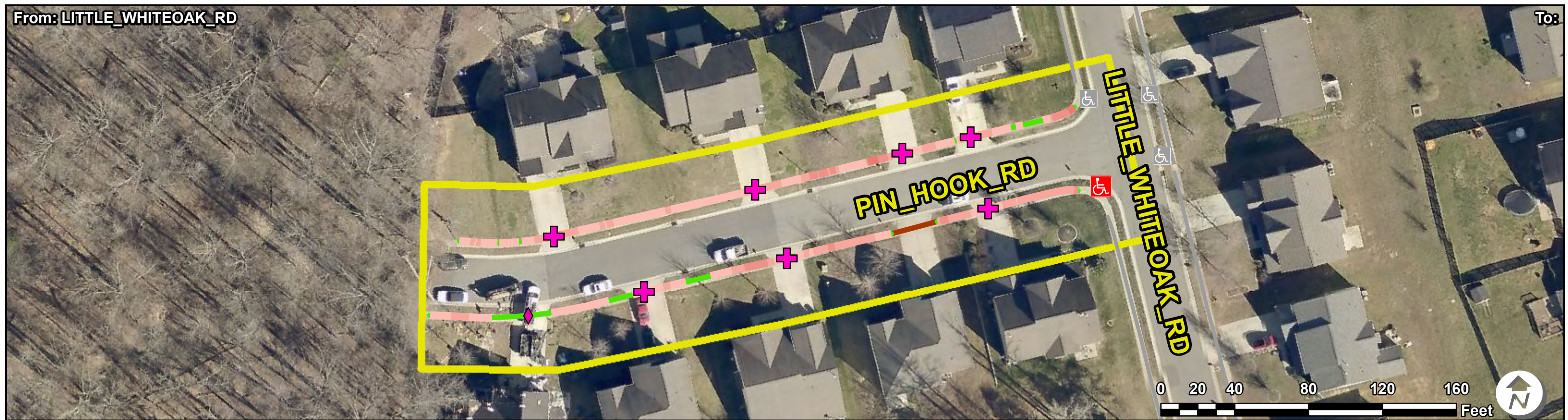

***Note: Excluded items are violations that occur in areas with slope violations and have been excluded from the cost estimate.
