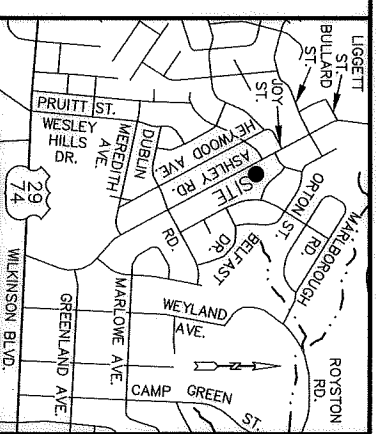

 NOT TO SCALE

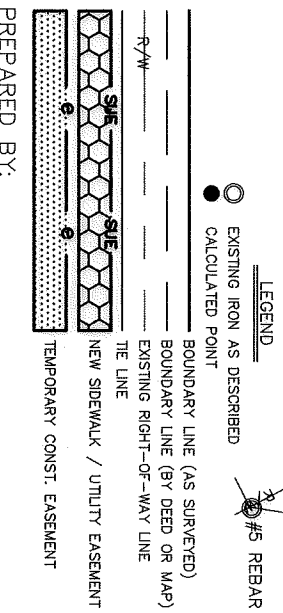
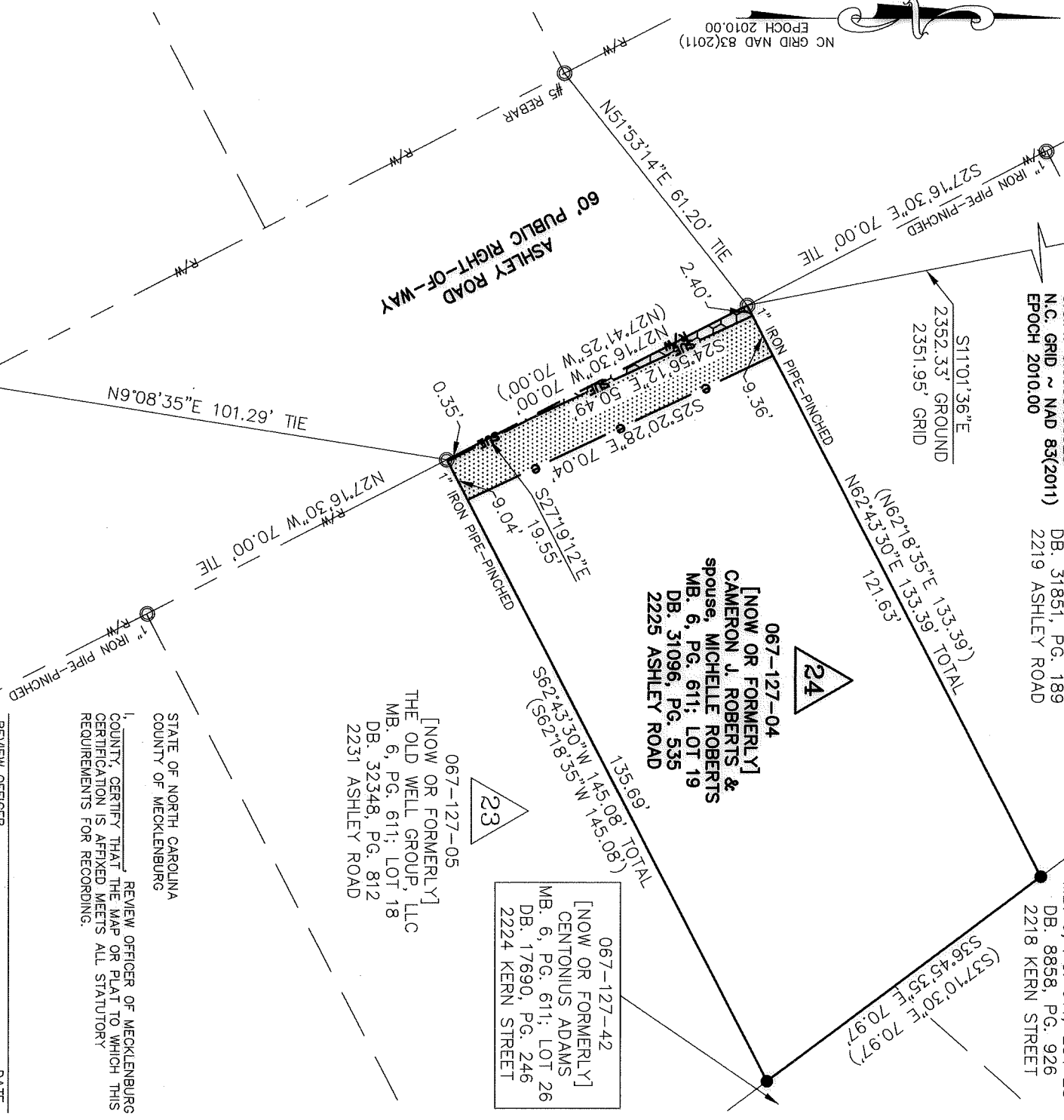
