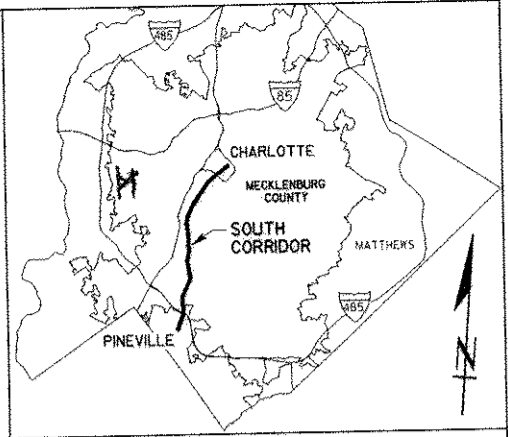

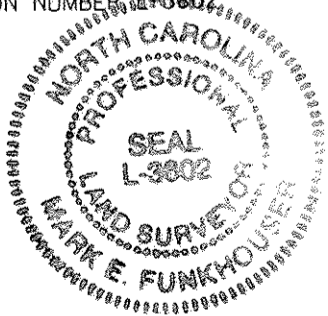


VICINITY MAP
