

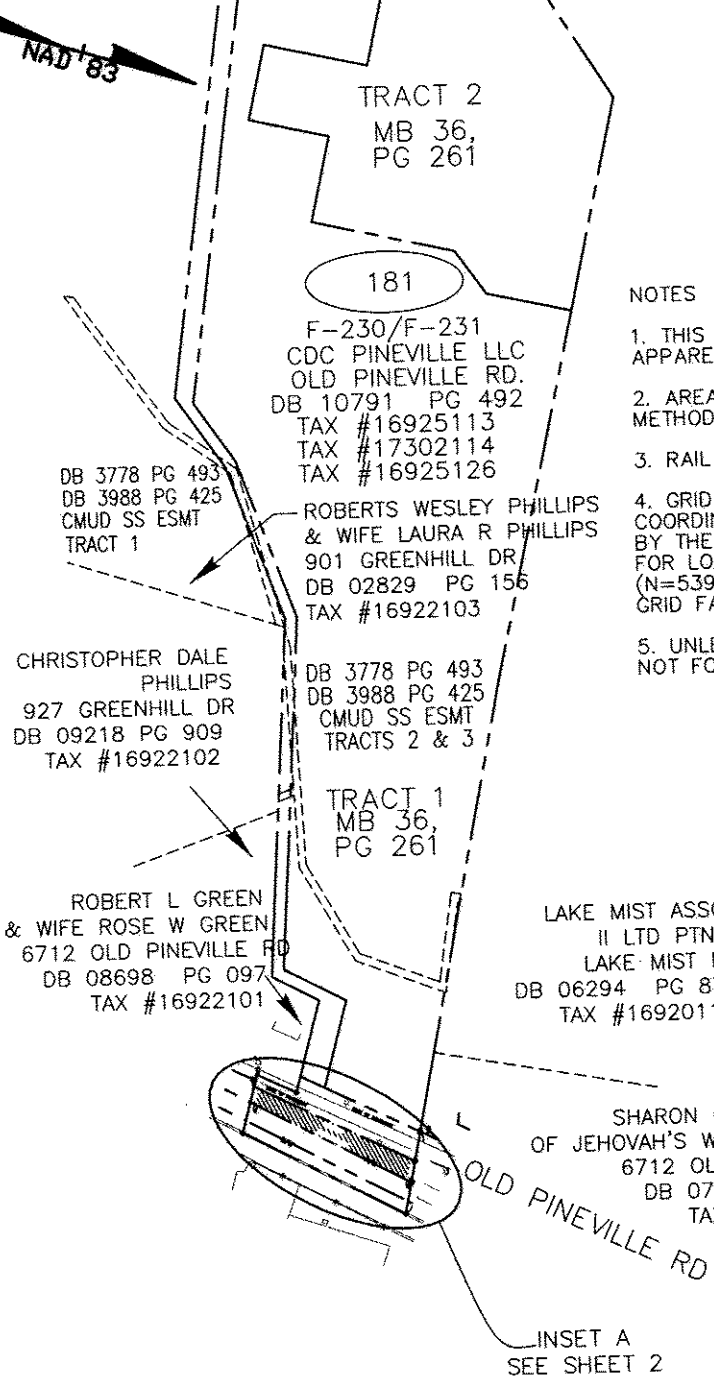
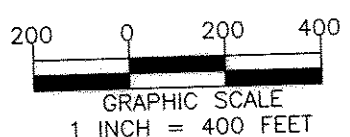
VICINITY MAP
