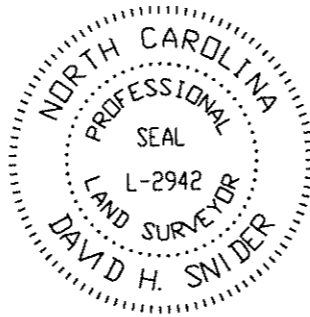

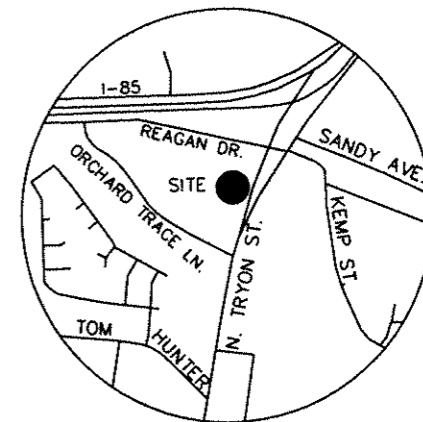

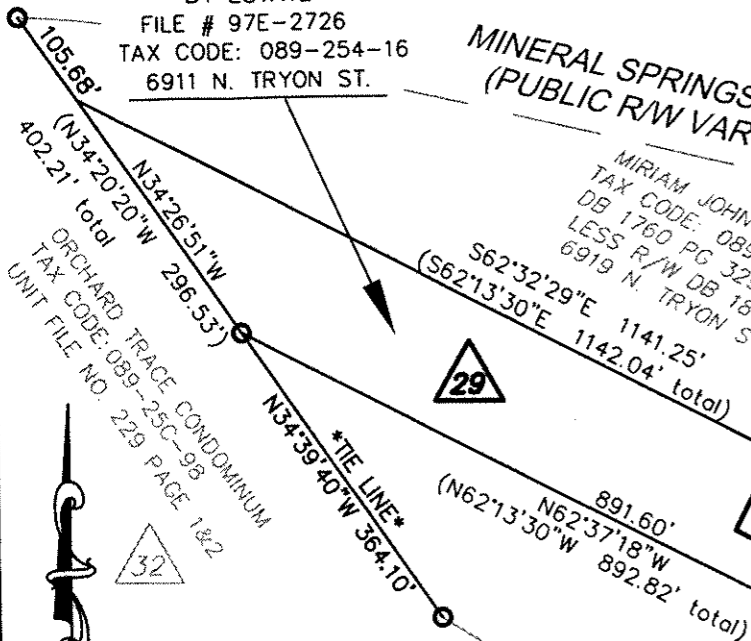


VICINITY MAP

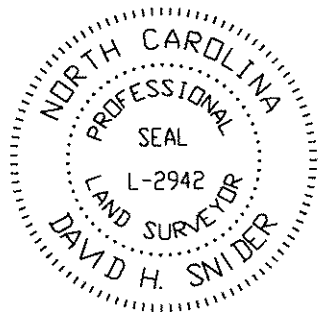

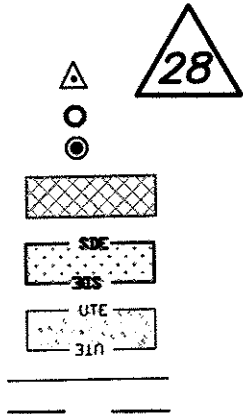
