**A RESOLUTION PROVIDING FOR A PUBLIC HEARING DECEMBER 19, 1960,
ON A PROPOSED AMENDMENT TO THE ZONING ORDINANCE.**

(3356 Westfield Road)

WHEREAS, at the meeting of the City Council on November 14, 1960, the following amendment to the City Code was introduced:

Ordinance No. 709, An Ordinance Amending Chapter 21 of the City Code - Zoning Ordinance
An Ordinance Amending the City Code with Respect to the Zoning Ordinance.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That Chapter 21, Article I, Section 2 of the City Code of the City of Charlotte, (O. B. 10), be amended by changing from Residence 1 to Office-Institution the following described property: Being all of Lot 6 in Block E as shown on a map of Myers Park Manor recorded in Map Book 5, Page 215 in the office of the Register of Deeds for Mecklenburg County, North Carolina.

Section 2. After this ordinance shall become effective upon its adoption after a public hearing in connection therewith.

AND, WHEREAS, under the law no amendment to the zoning ordinance can be adopted until a public hearing thereon is held, of which public hearing notice is required to be given publication not less than fifteen days immediately preceding the date of such hearing:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

1. That December 19, 1960, at 2 o'clock p.m. be fixed as the time, and the Council Chamber in the City Hall as the place for the public hearing on the proposed amendment as above set out.
