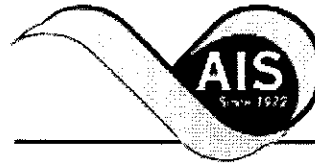

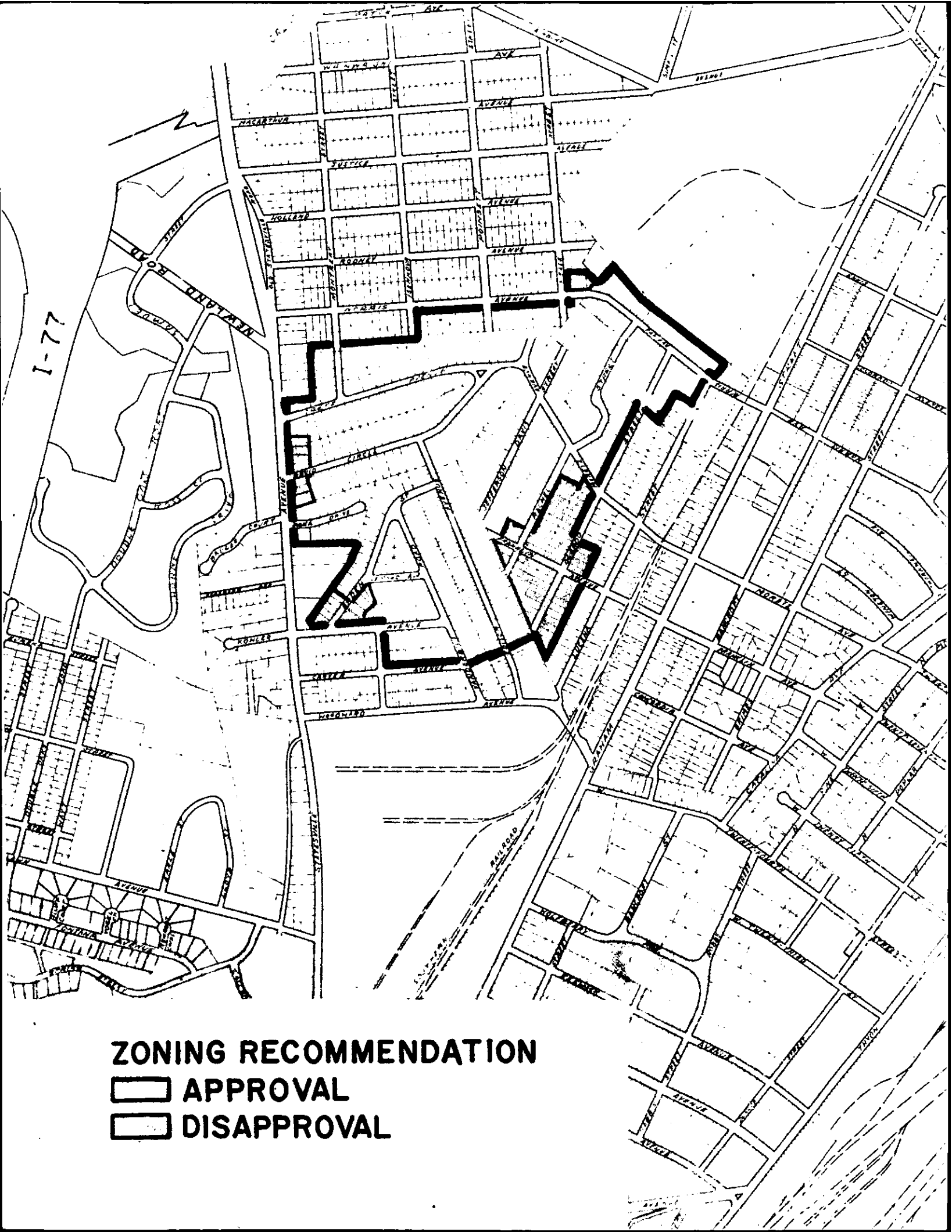


The Druid Hills Action Committee filed a rezoning petition (No. 73-40) with the Charlotte-Mecklenburg Planning Commission on September 6, 1973. The Public Hearing for the petition was held on Monday, October 15, 1973, at which time there was no opposition made to our request, only one person requesting his property on Statesville Ave. be removed. Two spokesmen for the Druid Hills Action Committee appeared and spoke in favor of the rezoning petition. We collected 282 signatures, including 160 owners of 170 parcels of land in the area.

We have heard no official word on why the Planning Commission has not acted on this matter, though we understand that some members of the Planning Commission wanted more information - even though there was no opposition to the petition. We know that the Planning Commission has met several times since the Public Hearing and wonder why our petition has been neglected.

Please consider our rezoning request at your next meeting, and notify us of the exact time, date and place of such consideration. Since Planning Commission meetings are public meetings (open to the public), we want to have a representative at the meeting of the Planning Commission when you discuss our request and make your decision. 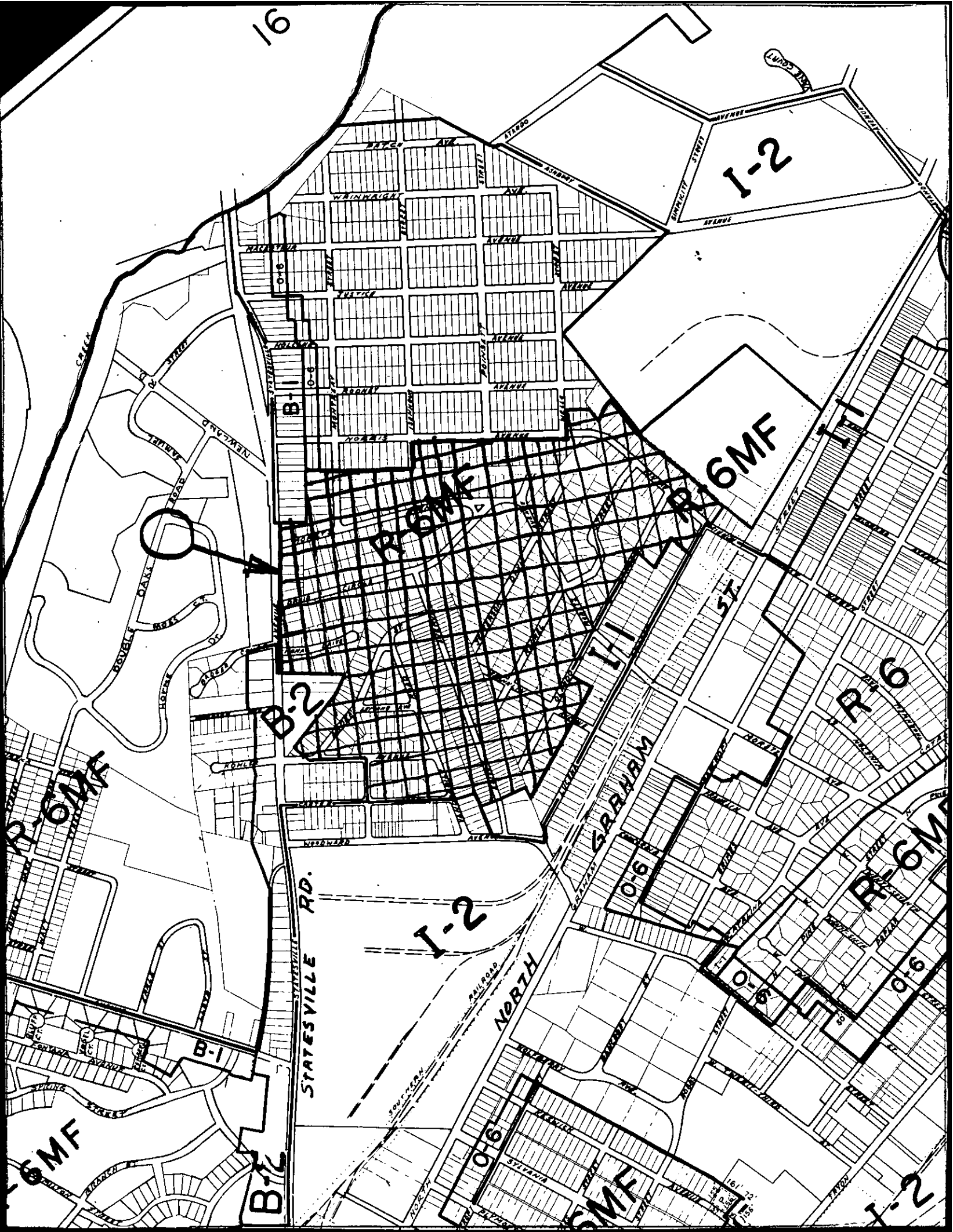
