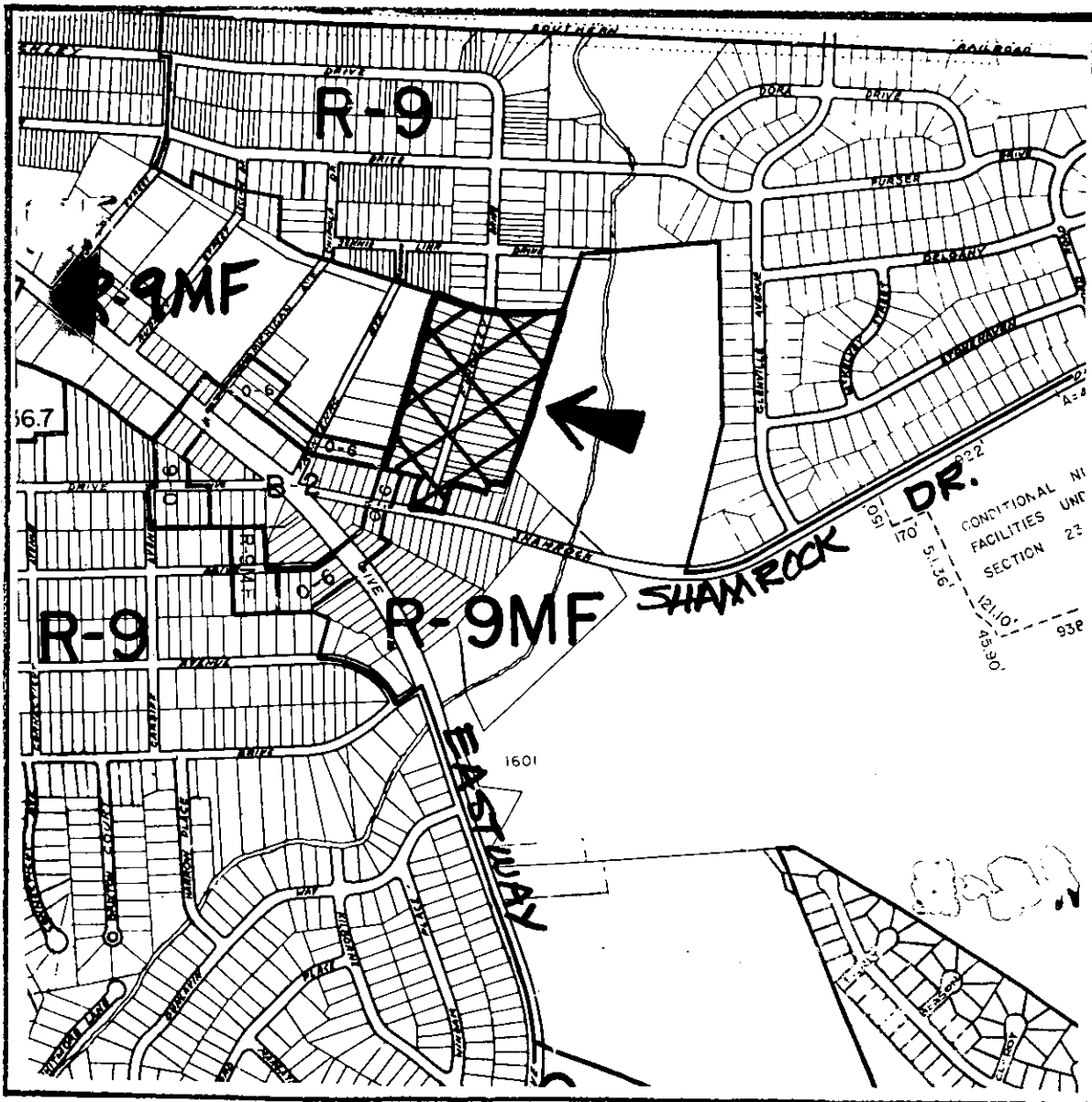

LOCATION The area along both sides of Finchley Drive between Shamrock Drive and Jennie Linn Drive

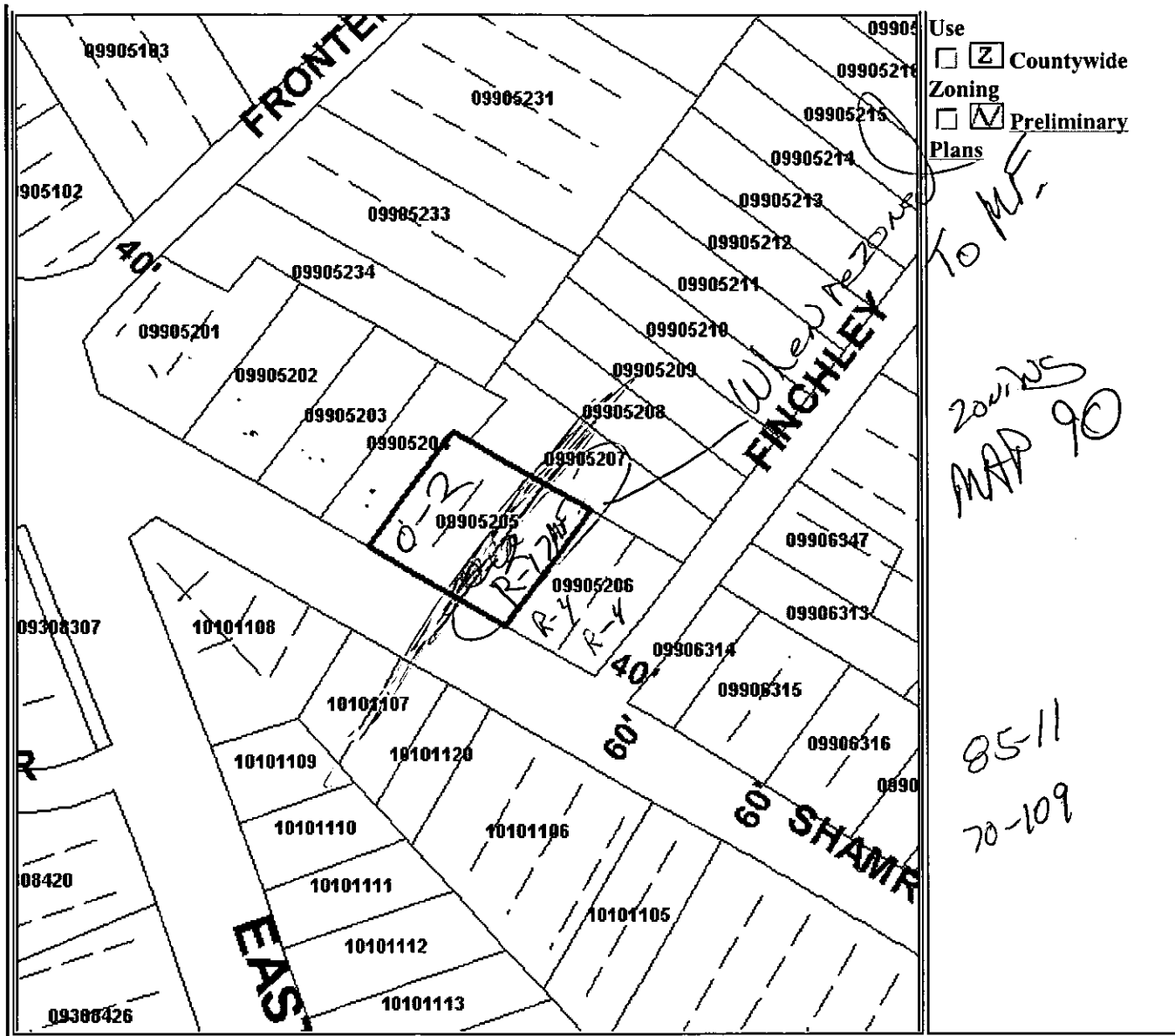


ZONING MAP NO. 20
