## A RESOLUTION AMENDING THE MECKLENBURG COUNTY ZONING REGULATIONS

WHEREAS, the Board of County Commissioners has authority to amend the Zoning Ordinance by Chapter 6, Part 1 and a public hearing was held on December 9, 1997; and
