present, tenant advised there was a grease fire in the kitchen over a month ago and she has been living with the kitchen fire damaged for over a month, and once she called the complaint they came out and made the repairs. She showed me photos of the fire damaged kitchen, however everything in the kitchen has been repaired. Management removed the stove due to the fire and have not replaced it yet, advised the tenant we cannot enforce the fact that she does not have a stove, she advised she has a family to cook for, however we cannot enforce it if its not in the ordinance. She then stated their is a busted pipe between her unit and the one below her, she advised her carpet is always wet and molded. Did not feel any evidence of wet flooring within her unit, and advised her that we cannot inspect for mold. She stated her neighbor below her wanted me to inspect her unit while i was at the property, advised i could not inspect until the tenant calls in a compliant. Did not see any other
