Connecting Charlotte

This Permit is subject to the following conditions:

1. Activities in the Right of Way which involve closure of a lane of traffic or sidewalk WILL NOT BE ALLOWED between the Peak Traffic hours of 7-9 am and 4-6:30 pm.

2. Cutting the sidewalk or pavement requires 24-hour advance notice and a permit obtained from CDOT's Street Maintenance Division (704) 336-4025. All sidewalk replacement must be performed in accordance with City standards and inspected by SMD for proper compaction before pouring.

3. Excavations and/or boring operations in the R/W require that underground utilities be located prior to commencing work. Mark the excavation area with white lines then call the NC One-Call Center at (800) 632-4949, and CMUD (704) 336-2564 at least 48 hours in advance of planned work. In addition, CMUD requires using soft-dig methods to vertically locate their facilities when working in the vicinity of their facilities.

Failure to comply with these conditions may result in the revocation of this Permit, fines, penalties, denial of future Permits and other actions as deemed necessary.
