> I responded to a check compliance at 7600 Old Plank Rd, in reference to a permit inspection. Upon arrival, I made contact with the livestock owner, Michelle Beman. I was shown to the backyard, where there were 90 birds on the property. There are currently three large chicken coops (10ftx20ft) in size, where the chickens and guinea hens are being kept. The coop and runs are very clean and offer plenty of space for the birds to roam. There is a second smaller coop (8ftx5ft) that holds 30 Quail. This coop is also very clean and spatious. The quail will be moving to a bigger coop that is currently under construction. Ms. Beman owns a total of 18 acres, and there are currently no neighbors in the area. The coops are within legal limits.
